Jear in Review

- **Celebrated the 25th year of the IFSG.** In the mid 1990s, John Lanterman envisioned bringing the Feng Shui community together, and therefore formed the Feng Shui Guild in Boulder, Colorado. While meeting over lunch during a mid 1990's conference, John and others realized they shared similar views, visions, desires, and intentions for the Feng Shui community creating the tenet of all inclusive perspectives we still hold in high regard today.
- Offered the second year of the very successful Spotlight Series with a record number of five presenters. This series offered special events throughout the year from member presenters and non-member presenters on a wide variety of topics. Host team members included board members Wendy Yawching, Tori McBrien, and Deb DermyerLamb.
- Took on the daunting task of moving from our long-time web hosting company to a new more responsive hosting company. While the end result was successful and offered the IFSG a safer and better protected online experience; the process was not without many bumps and bruises, the worst of these including challenges for Comcast internet users being able to access the site easily. After several months of tedious investigation, meetings, and rework, the site was cleared and all customers members and the public were greeted with a smooth faster website.
- **Redesigned the member experience** on the member section of the website to make it easier to find what members need the most, centralize common topics and benefits, and simplify the process of updating profiles and entering events. Streamlined products and eliminated redundancies.
- Rebuilt both the consultant directory and school directory member by member; school by school. The goal was to create a higher search engine ready platform with added filters, functionality, speed, and improved location search options – all of which were accomplished by the office.
- **Developed a new initiative for our YouTube channel** to better present member expertise and build our viewership. Spearheaded by board members, Kim Julen and Tori McBrien, the templates and process make it easy for members to submit their full video for distribution and social media maximization.

- Hosted a first ever IFSG Town Hall for members to talk and brainstorm with board members regarding what they love most, don't understand, or want to learn more about what we do and how it affects them and their business. Many amazing takeaways were gathered and will be implemented into future initiatives by the board.
- Offered a one-of-a-kind fun and engaging experience in the 12 days of giveaways. Participating members claimed free weeks of membership, discounts on products, free resources, and promotional tangibles celebrating the 25 years of the IFSG.

There were a number of headwinds that prevailed in 2022. A challenging inflation outlook put downward pressure on the global economy as it struggled against a tide of higher interest rates and a softer labor market. Moreover, there was lingering uncertainty regarding the path out of the softer economic condition that were exacerbated by the start of a worrisome war in Ukraine. As such, the IFSG's financial position managed to hold up surprisingly well in 2022.

The IFSG ended 2022 basically in balance which was an improvement from 2021. Net income was flat as compared to the \$4.3K loss of 2021. The trend over the three years from 2019 has been steadily improving which is very encouraging given the economic tumoil of the time. A robust marketing campaign yielded an improvement in membership dues, which is the primary source of income for the IFSG. It is particularly encouraging that school-based membership, which has been a big focus for the IFSG in the past few years rose a whopping 19% as compared to 2021 as it continues to see positive upward momentum. Professional memberships were almost virtually unchanged from 2021 as it was up modestly to \$18.6K from \$18.5K in 2020.

Another source of encouraging news was the continued demand for the spotlight speaker series which saw a 6% increase in revenue. This suggests that the hard work of topic development and gathering the talent has paid off not only to the IFSG's bottom line but also those who have been able to access the product and learn from it.

In terms of expenditures, there was only one major category that caused expenditures to rise in 2022 and that was software maintenance. Most other large categories such as labor costs were largely in line with 2021 spending.

The marketing team continue to work tirelessly to bring new product lines to members. The Spotlight Speaker series remains a key product as it offers a number of diverse and experienced speakers wishing to share their knowledge. Moreover, the IFSG Summit offers a similar avenue for income growth as it will surely be met with keen interest.

Moreover, the effort to retain existing members and bring in new membership from recent Feng Shui graduates of affiliate schools is expected to help underpin growth in the income stream for 2023. Membership revenue primarily from individuals continues to be a key source of income for the IFSG and the ongoing efforts to work with feng shui schools to encourage students to join the guild will surely add to the income stream.

There is no expectation for large-scale expenses to hamper the expense side of the ledger. Outside of computer hosting expenses, we do not anticipate much change on this front.

The outlook for 2023 appears to have more positive features than the last two very difficult years. Not only has the pandemic and its complicated economic implications receded but the key hurdle brought about by strong inflationary headwinds appear to have slowed somewhat. But despite the encouraging seeds of improvement, we are nevertheless taking a cautious approach to the forecast. Inflation, which is slowing in pace, is still an issue in the economy and that has affected economic growth. But we firmly believe the caliber of products in addition to the new structure of the website justify the forecast to expect that the balance sheet will continue to improve in 2023. As such, we expect a modest rate of growth of somewhere around 2% for net income.
